

2/ Ferry Farm Community Solar Project CIC acquisition and re-finance


Acquisition of Ferry Farm Community Solar Project CIC

- Completed 27th March 2020
- Funded by short-term loan from Leapfrog Bridge Finance
- Places the community solar farm fully into the ownership of Ferry Farm Community Solar community benefit society


Following completion of the acquisition, the shortterm loan from Leapfrog Bridge Finance was refinanced by:

- £5.06m loan from Triodos Bank
- £850,000 community bond offer through the TriodosCrowdFunding (at 4%)

This completes the long-term financing of the community solar farm.




Structure before acquisition and refinance

SUPPORTING THE COMMUNITY THROUGH THE CORONAVIRUS CRISIS

Some of the Ferry Farm Coronavirus Crisis Fund grants:

£6,000

Provided to Selsey
Community Forum, who are
co-ordinating the Covid Mutual Aid
network for Sesley and Sidlesham.
£1,000 of this is to contribute to the cost
of running the network and £5,000 is
an initial contribution to a crisis fund for
families facing financial difficulty. This
funding will be provided directly to
families in need to cover short-term
crisis cash needs.

On the day the schools were shut down, a donation of £1,500 was made to The Academy, Selsey to pay for a subscription to an online library to enable students to access contemporary reading materials whilst at home.

E9,000 was used to purchase 40 laptops for our local schools (The Academy, Selsey, Medmerry Primary School, Seal Primary Academy and Sidlesham Primary School). These devices have been provided so they can be lent to students that may not otherwise have access to online learning resources whilst at home.

£10,000 has been allocated to Chichester Food Bank to support its operation in Selsey and Sidlesham.

£1,700 was awarded to Selsey Downs Syndrome Support Group to pay for laptops or tablets for children without their own device to enable the group to provide support remotely.

"We were thrilled to be awarded such a generous amount. We have almost reached our target to purchase and fully equip an animal ambulance rescue vehicle. We hope that by the summer we will have raised the remaining funds and have the vehicle up and running.

This donation will make a huge difference to us and helping wildlife in our local area. Wildlife is in dramatic decline so we hope that by providing a rescue service we will be able to help more wildlife casualties in need."

"The PADS are housed in metal cabinets, not ideal in a seaside resort, so revolutionary new outdoor waterproof public access defibrillator cabinets, manufactured from polycarbonate (the same material used for police riot shields) will provide a fully water and dust tight solution.

There is no government or NHS funding for your voluntary responders so we were absolutely delighted to learn our grant application had been successful."

Community projects supported – SCF grant fund

- •Sidlesham Community Association to purchase all weather picnic tables for refreshments served to those using the Memorial Playing Field £1,890
- •Selsey Community First Responders funding towards the replacement of metal defibrillator cabinets with polycarbonate ones, better suited to Selsey's climate £2,000
- •Selsey Buddy Support funding continuing support for Selsey's most vulnerable and needy residents £2,000
- •Selsey Befriending Activities funding towards the provision of support and activities for the vulnerable and elderly £1,000
- •Selsey Carers Support funding ongoing support and social interaction for unpaid carers to relieve stress and isolation £1,000
- •Selsey Wellbeing Services funding ongoing support of young people's mental health and wellbeing £1,000
- •Selsey Community Forum recording and making available present and future care plans to improve the care of those in need, particularly those with communication difficulties 1,000
- •Selsey Dementia Action Alliance provide ongoing support to those living with dementia and unpaid carers £1,000
- •Selsey Money Support provide ongoing one-to-one comprehensive support and advice for those in debt £1,000

- •Selsey Cricket Club All Stars Cricket training for the next generation of colts £400
- •Brent Lodge Wildlife Hospital funding towards a specially adapted animal ambulance £1,250
- •Selsey Men-in-Sheds for the purchase of tools and equipment to enable an increase in the number of members £500
- •Manhood Wildlife & Heritage Group to provide a Heritage Trail leaflet, display materials and signage for the Heritage Trail Centre £1,120
- •The Bridge's Dance Live Team, The Academy, Selsey to partly fund a storage container for stage sets and costumes £500
- •Grow Selsey development of a local service enabling families to access resources needed to grow healthy, sustainable food £2,000
- •Arts Dream Selsey to revive and restage 'Tonight Charlie Chaplin at the Pavilion' £1,300
- •Youth Dream funding a Youth Club in Selsey and Youth Worker to provide an evening safe space for young people £1,000




4/ Future plans for use of surpluses
